

LIST OF FISHERY ASSOCIATIONS IN THE UNITED STATES, ALASKA AND HAWAII

This list includes only fishery associations of fishermen and vessel owners (which are not cooperatives) and associations of wholesale and retail dealers, processors, distributors, etc. The list was compiled July 1947, and the latest revision was made in August 1956. It may not be complete since there is a constant change in associations as new ones are formed and old ones become dormant or dissolved. Therefore, the Fish and Wildlife Service assumes no responsibility in supplying the list to inquirers. Information on changes may be secured from the Branch of Commercial Fisheries, Fish and Wildlife Service, U. S. Department of the Interior, Washington 25, D. C.

In addition to this list of associations, there is available Fishery Leaflet 292, List of Fishery Cooperatives in the United States and Alaska. Fishery Leaflet 292 includes only fish producers' cooperatives. It should be noted that some of the activities of fishermen's unions, which include boat operators among their membership, are in the nature of fishery cooperative marketing and have been considered as such by Federal courts\*.

There is also available Fishery Leaflet 293, List of Fishermen's and Fish Shore Workers' Unions in the United States, Alaska, and Hawaii, which includes only trade unions.
