## Explanatory Statement

This list includes fishermen's and fish shore workers' unions only. The list was originally compiled in February 1948, and the latest revision was made in August 1962. It may not be complete since there is considerable change taking place among fishery unions as some become dormant or are dissolved, new unions or branches are formed, or affiliations are changed. Therefore, the Fish and Wildlife Service assumes no responsibility in supplying the list to inquirers. Information on changes may be secured from the Bureau of Commercial Fisheries, Fish and Wildlife Service, United States Department of the Interior, Washington 25, D. C.

In addition to this list of unions, there is available Fishery Leaflet 254, List of Fishery Associations in the United States. Fishery Leaflet 254 includes only associations of fishermen and vessel owners (which are not cooperatives), processors, associations of wholesale dealers, distributors, etc., and retailers.

There is also available Fishery Leaflet 292, List of Fishery Cooperatives in the United States. Fishery Leaflet 292 includes fish producers' cooperatives only. It should be noted that some activities of certain fishermen's unions, which include boat operators among their membership, are in the nature of fishery cooperative marketing and have been considered as such by Federal courts\*.
