OVERVIEW OF ADDENDUM CONTENTS

This document provides updates to the recreational impacts and expenditures tables of the Fisheries Economics of the United States 2016 report. The revised tables reflect changes to:

- The number of trips in Marine Recreational Information Program (MRIP) states and slight revisions to the trip estimates in other states.²
- Updates to the average trip expenditures based on new survey data.
- A new economic impact model for every state.

¹An earlier version of this addendum was published online in September 2019. This revised version includes updates to jobs and sales numbers for the Pacific Region and California. Table rows with updated numbers are footnoted on page 6.

²**Total annual trip expenditures** are estimated at the state level by multiplying mean trip expenditures by the estimated number of adult trips in each trip mode (for-hire, private boat, and shore) and adjusting by the CPI (consumer price index) to the current year. **Total annual durable expenditures** were estimated by multiplying mean durable expenditures in each state by the estimated annual number of adult participants for each state and adjusting by the CPI (consumer price index) to the current year.
